**ORDER**

Provisional recognition is granted to Sri Guru Gobind Singh Public School, Sector 35-B, Chandigarh for 04 years i.e. up to 31.3.2027 under Article 235 read with 241-A of Punjab Education Code subject to the condition that the school should ensure that all the conditions as given below are complied within six months before the expiry of the extended period of recognition failing which further recognition would not be considered -

1. Provisions of RTE Act and other instructions issued by the Education Department related to admission of students under EWS category and disadvantaged groups be followed in letter and spirit (wherever applicable).
2. Managing Committee should be got approved from the Education Department from time to time.
3. Reserve Fund is to be pledged in the name of DEO, U.T., Chandigarh as per rule.
4. School will follow the provision of Rules of Recognition of Punjab Education Code.
5. School will follow land allotment conditions and other notifications/ orders/instructions issued by the Chandigarh Administration from time to time.
6. School will recruit teachers as per NCTE notification dated 12.11.2014 as amended from time to time regarding minimum qualification of teachers including the qualifications prescribed for teachers including the qualifications prescribed for teachers at pre-primary level as per letter dated 02.04.2018. The teachers recruited after August 2010 should have Qualified TET/CTET.
7. Instructions/guidelines issued by CBSE relating to books/uniforms are to be followed.
8. No particular book shop be prescribed for purchase of book/uniform etc. by the school.
9. Fire Safety Norms be followed meticulously and there should be no laxity in this regard on the part of the school.
10. Fee should be charged from the students as per CBSE Affiliation Bye Laws and receipt be issued to the students against the money charged from them.
11. Recognition is liable to be withdrawn if the management or the staff of the school take part in agitation against the authority of Government, or disseminate opinions tending to excite feelings of disloyalty or disaffection against Government or of enmity and hatred between different classes or if the pupils are permitted to attend political meetings or to engage in any form of political or communal agitation;
12. Government reserves to itself the right, to grant, refuse or withdraw recognition at its entire discretion.

**The recognition is also subject to the following conditions: -**

1. The management will not add any more class/section to the school without the permission of the department.
2. The school will send a quarterly report regarding the progress made towards the fulfillment of various conditions mentioned above.
3. The school will not be transferred to different building or locality, not already approved by the Department.
4. The school will not be transferred to a different Managing Body already approved by the Department.
5. In case the conditions imposed are not fulfilled or the Institution commits some irregularities during the course of the year, the recognition can be withdrawn at any time.


